Dear Supplier, Calzaturificio San Giorgio S.r.l., as data controller, hereby informs you that, pursuant to Article 13 of EU Regulation 2016/679 on personal data protection (hereinafter Regulation), for the establishment and the execution of the contractual relationships in progress is in possession or may be subsequently informed of information referred to you.

**1. Type of data processed**

The following personal data may be processed: personal data, tax, address, bank details and other administrative or commercial data necessary for the purposes indicated below.

**2. Purpose of the Data Processing**

The data will be processed for the following purposes: fulfillment of legal obligations and execution of the contract of which you are part of, fulfillment of obligations towards the State's financial administration, accounting and administrative management, management of existing business relationships and management of litigation.

**3. Legal Basis**

The legal basis process is constituted by the execution of the contract and by the need to fulfill the obligations established by the regulations in force.

**4. Conferment**

The provision of the requested information is mandatory to fulfill the legal and contractual obligations, therefore any refusal to supply them will make it impossible for the undersigned to execute the contract or to correctly perform all the obligations required by the purposes indicated in point 2.

**5. Storage Time**

The data will be collected and stored for the period of time necessary for the pursuit of the purposes indicated above and, in any case, not beyond the deadlines set by specific legal obligations.

**6. Recipients of Personal Data**

The personal data will be processed by staff, duly instructed and operating under the authority and responsibility of the data controller. Some of the information may be communicated to the following subjects:

- Public bodies (Tax offices and other bodies);
- Companies, legal or consulting offices to which the Controller has given a specific mandate;
- Computer assistance and maintenance company or IT storage system providers;
- Other subjects or companies that perform activities instrumental to the purposes indicated above.

## 7. Rights of the Data Subject

In accordance with Article 77 of the Regulation, moreover, you have the right to file a complaint with the Data Protection Authority if you believe that the processing violates the aforementioned Regulation.
